How does Washington Trust Advisors protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. These physical, electronic & procedural safeguards were created to protect your information. We also limit employee access as appropriate.
